Fee Structure - International Students

- Registration Fee \$ 1000 (non-refundable)
- Administraive Fee \$2500 (refundable *)
- Tuition (maximum of 8 credits / year) \$ 10,000 / year (* refundable)
- Annual medical insurance \$ 600 per year (* refundable)
- Legal documentation costs relating to custody \$ 250 (non-refundable)
 Annual custody fee \$ 1200 (refundable *)
- Shared accommodation with 2 meals a day \$ 12,000 / year + security deposit of \$ 1000
- international courier fee (deductible before refund) \$ 100 per document / mail

Note: travel and tours, transportation, textbooks, photocopying and pocket money of the students are not included in the fees mentioned above and must be arranged by the student from time to time.

Refund Policy

Registration fees and conservation of legal documentation (if any) are not refundable.

- Annual fees, school fees, medical expenses and childcare costs (if any) are fully refundable only in case of rejection of the permit application review. In case of refusal,
- The student must provide the letter of refusal issued by the center / Canadian Immigration consulate with the original acceptance letter, the original letter of offer, the original copy of repayment as well as details of the beneficiary's bank account, there including the codes to be issued.
- If the applicant decides to withdraw from school prior to the filing of the application for a study permit, annual fees, tuition fees, medical insurance costs and annual custody fee (if any) will be partially refunded after deduction of administrative costs.
- Students whose application for a study permit is approved will not be entitled to any reimbursement for tuition and child care.

Application Procedure

All candidates for admission must complete all pages of the paper application form, pay a non-refundable registration fee of \$ 1000 and the registration form, a copy of valid passport, copies of all Canadian visa Certificate of birth (if available), language outcomes (p. Ex. IELTS, TOEFL or equivalent, if available) and all transcripts and report cards from grade 8.

The offer letter is issued within two working days of receipt of the completed registration form, the registration fee and the required documents. The formal acceptance letter is issued the business day following the confirmation of the filing fees of our bank.
